The Court also elected Mr George Godfrey as our new Clerk and appointed Mr Maceo Frederick, our former Deputy Clerk, as Treasurer.

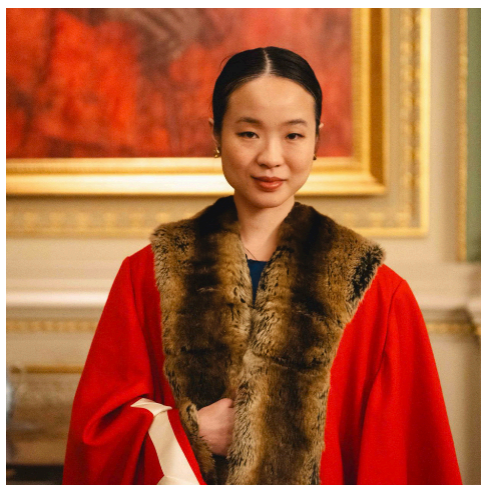

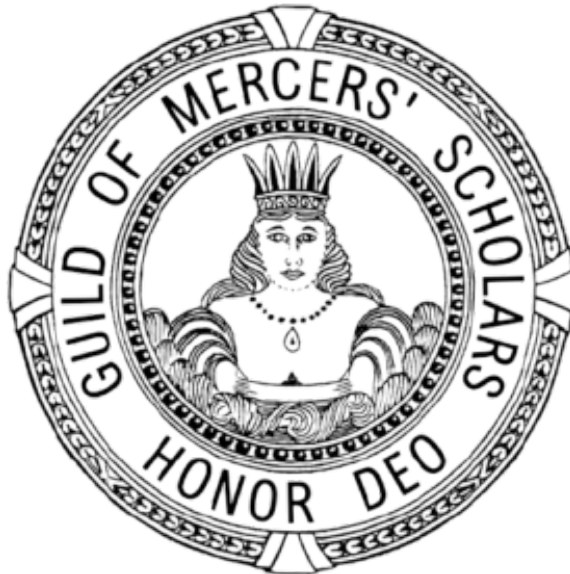
many other former Young Freemen in a wonderful celebration of tradition and community.

## Jocelyn Stuart-Grumbar's Speech from the Inaugural Reunion Banquet

They say that 'Talking is the craft. Listening is the art.' Well, I'm working on the **Craft** and I'm really hoping that you're already consummate practitioners of the **Art**!

It really is such a privilege to have been asked to speak at this, your first, **Reunion Dinner**. I believe that the idea of holding a Reunion Dinner was strongly encouraged the incoming Chief Commoner, **Deputy Henry Pollard**.

Before I go any further, and ahead of their Installation on 21<sup>st</sup> May, I would like to congratulate **Reuben Braden-Bell** on his Election as Master of The Guild and also Court Assistant Miss **Jacqueline Chan** on her Election as Renter Warden.

In my only Dickensian flourish of the evening, I would conjure Dickens' fabled opening words from **The Tale of Two Cities: 'It was the best of times, it was the worst of times'**. Well, which is it for us? It won't surprise you to hear that I do not reach a firm conclusion, but I DO seek to shed a little cause for optimism!

I'm not someone who spends a lot of time looking back, but next year is The **Guild of Young Freemen's 50th anniversary**. I was one of the very early members of what was then The **Society of Young Freemen**, so a look in the rear-view mirror is probably called for. But I promise that, once we've revisited the 1970s, I'll do my best to bring my drone down in the fertile terrain of the future.



Back, first, to the Society. A couple of abiding memories are of there being a frequent need to explain our name and that the **society-of-young-free-men** was not some sort of dating agency and that, yes, women were involved, too!

I vividly remember our taking part in the **Lord Mayor's Show** for Sir Robin Gillett, sporting bright red sweatshirts, with SYF embossed on them in white foam lettering, together with cardboard bowler hats. This was in an age when being given a freebie sweatshirt was really rather exciting!

The Society was great fun, and one of the ways of meeting others. Strange though it may seem, meeting people took place **almost entirely in the real world** - at work or at play. There really wasn't any other way!

People help to anchor us in time. To remind ourselves just how long ago 1976 is, let's see which stars arrived in or left the UK firmament in that year:

#### **Born in 1976 were:**

Keeley Hawes, Sir Chris Hoy, Alan Carr, and Benedict Cumberbatch,

#### **And, taking their leave, were:**

Agatha Christie, L S Lowry, General Montgomery, and Benjamin Britten

Often, in the last few months, we have been tempted to feel that the World and our own country are in a pretty perilous place. However, the late-'seventies was a turbulent and uncertain time, too. Leonid Brezhnev was still ossified to the levers of power in the Soviet Union; as was Mao Ze Dong in China, where the Cultural Revolution was ongoing; and the siege of Jimmy Carter's American Embassy in Teheran lay just ahead.



But the world at large is too broad and perplexing a palette for us tonight. So, let's try to situate ourselves back in UK of the 'seventies - infamous for the 'Three-Day Week' and 'The Winter of Discontent'.

May I invite you to join me aboard the then brand-new Intercity 125 train - still with the famous slamming doors - on a whistle stop ride through 1976. To hit and maintain our much-vaunted speed, you'll be glad to know that we won't stop at all stations on the way!

The year got off to a bracing start:

#### **All within the very first month of the year:**

- **Hurricane**-force winds of up to 105 mph killed 22 people.
- The **Third Cod War** saw British and Icelandic ships clash at sea.
- The first commercial **Concorde** flight left Heathrow for Bahrain.
- And, there were 12 **Provisional IRA** bombs in London's West End.

#### **In March:**

- A 29-year-old Prince of Wales cut the ribbon at **Brent Cross Shopping Centre**.
- And Anita Roddick opened the first branch of **The Body Shop**, in Brighton.

#### **In April:**

- The UK won the Eurovision Song Contest for the third time with the song 'Save all your kisses for me' by Brotherhood of Man.

#### **In June and July:**

- Saw temperatures attaining at least 26.7 °C every day.

In London, for five consecutive days, the **temperature exceeded 35 °C** (or 95°F as we used to call it, as it sounded much more impressive!). These were early intimations of **Climate Change**.

#### **In August:**

- 10,000 Protestant and Catholic women demonstrated together, for **peace in Northern Ireland**.

- 100 police officers and 60 carnival-goers were injured during riots at the **Notting Hill Carnival**.
- The **Grunwick Strike**, which was to last until June 1977, started during this month. Do look it up – it's a fascinating story.

### The month of October:

- Saw the opening of the **National Theatre** on the then undiscovered South Bank.

### And – totally exhausted – we now reach December:

- Punk band the **Sex Pistols** achieved notoriety as they expleted several swear words live on TV, following the release of their debut single *Anarchy in the UK*.
- Chancellor of the Exchequer **Denis Healey** announced that he had successfully negotiated a £2.3 billion loan from the **International Monetary Fund** on condition that £2.5 billion was cut from public spending.
- **Inflation** stood at 16.5% – one of the highest since records began in 1750.
- ...and, in a rather odd choice of month, December saw the opening of Rutland Water, the largest reservoir in England.

To sum up the sense of the nineteen-seventies, there's a truly awful joke from that time:

***'Why did British-made cars have heated rear windows? To keep your hands warm when you had to get out and push!'***

As someone who is very much a 'glass half full' person, my purpose in painting this picture of a rather bleak time, is to say that, if we are indeed **going to hell in a handcart**, we've been doing so for a very long time! But, in fact, if you think about my tale of **strikes, bombs, riots, record temperatures, hurricanes, trade wars, persistent high inflation, and a bail-out from the IMF**, whilst there is no cause for complacency – especially in relation to such intractable challenges as climate or child poverty – most of the hallmarks of the 'seventies that I cite are not anything like such major features of the UK's situation today.

Whilst I was a member of The Society, as it then was, I did not actually work in the City, only doing so nearly 40 years later, when I joined **The Clothworkers'**, in 2015. During a number of long stints, I've had a lot of fun, including, in the 'eighties, being involved launching **J&B Scotch Whisky** in a then still pretty closed China and also in Spain in the years following the death of **General Franco**; then having a hand in developing Bombay Sapphire Gin; and, a bit later, being involved in setting up businesses for **James Dyson** in Spain, Italy, the USA and, as MD, in **China**. I then spent two in **Sheffield** with a technology start-up which we floated on the AIM market. It's still burning cash!

In a conversation yesterday about the Churchill Fellowships, their ethos of ***'Travel to learn; return to inspire'*** was cited. That's what I've been lucky to do – well, certainly the first part – and I strongly commend it.

So, for this lap, I'm in the vibrant and fast-changing City where, at Clothworkers', we are involved in the very exciting development on our freehold site, at **50 Fenchurch Street**, whilst seeing record grantmaking activity.

Whatever we each do – whether here in the City or elsewhere – we need to have a firm eye to the connectedness of the City of London to the **real economy**, and to our **manufacturing base**, if we and others are not to see the City as some sort of casino. Our collective stake in capitalism and the free market must not be taken for granted. The alternative has not served other societies well.

We can and do bridle at so much that we hear on the News. But I'd say a couple of things:

- When you think back to the picture I have painted of the 'seventies, we have made progress on so many fronts, and the tools that have since become available to us and those that we're on the cusp of embracing, will enable **further positive progress**, if we use them well.
- It would be easy to feel that we are buffeted around – the **prisoners of events**.

- However, if we are to realise the **immense promise** that science and technology offer us, we must not, for one moment, allow ourselves to think we have **no 'agency'**. As soon as we do that, we roll over.
- As individuals and, even more so, collectively, we do have the scope – and obligation – to **make a difference**.
- To do so, we need to **'be present'** – physically. The sense of purpose that is fostered in this way, is so powerful, energising and fulfilling.
- Change is bracing but essential. It should not lightly discard the **tried and tested**, nor fail to **learn from history** – which is littered with setbacks and new birth. Change need not be polemical nor adversarial. The most resilient change is that which **brings people with it**.

The very fact that you are here, brought together by an organisation that actively seeks purpose – that you encourage each other in your endeavours – means The Guild is in a really good place as it reaches its **50th birthday** next year. Much work has gone on to professionalise The Guild and to ensure it is reflective of a **meritocratic and inclusive City**. The **Middle Warden** tells me that a number of Companies have been extremely supportive along the way. These include The **Woolmen**, The **Basketmakers'**, The **Drapers'**, The **Apothecaries'**, amongst others. Your distinguished Past Honorary Presidents, Aldermen **Parmley**, **Wootton** and **Hailes**, and now **The Lord Mayor**, **Alderman Alastair King**, have been and

remain huge believers in what this body can bring to the affairs of the City and, so, the wider world the City seeks to serve.

It is a racing certainty that many people in this room will actually have a part in making the world an **unimaginably better place**.

There are a few watchwords that are worth reflecting on – they all seem to start with the letter 'i'! For me, these are **imagination, ingenuity, innovation, inclusion, inspiration, interdependency** – plus, importantly, a good dose of **irreverence**, especially when it comes to mediocrity and apathy. All of these will help us each achieve the biggest 'i' of all – that of **IMPACT**.

If so, someone standing here in another fifty years, at your centenary – when **Stationers' Hall** will probably look just as it does today – will be able to say that remarkable progress really has been made, and **you** will have had a hand in this.

And now, may I ask that we all join in a Toast to:

***The Guild of Young Freemen and the Master 'Root and branch, may it continue and flourish, forever.'***

## In Conversation with: Chief Commoner Henry Pollard On Civic Duty and the Future of the City

---

Henry Pollard's journey through the City of London is a tale of civic duty, global perspective and quiet transformation. A former member of the Guild of Young Freeman (from when it was a Society), Henry now serves as Chief Commoner — one of the city's oldest and most respected civic roles. With decades of experience internationally and in the Square Mile, Henry embodies the city's modern outlook on tradition. I had the privilege of speaking with him about his early career, time in the Guild, his passion for public service and why the values of the Livery (and its youngest members) are more relevant now than ever.

### **First impressions: From Choirboy to Commoner**

*"I first came to the City to sing at Skinners' Hall when I was a 13-year-old choirboy at Tonbridge School." Henry recalls, "There was a real Dick Whittington - dog meets sheriff - moment." The early encounter with civic and livery tradition planted a seed "I was fascinated by the old governments of the City and the representation of different trades from Medieval times to today." While the Skinners' Company is no longer involved in the fur trade, it supports eight schools and remains a living link to medieval times.*



## A global career in Commodities and Finance

Henry took an international trajectory, living in Paris, Mexico City, and Spain.

*"At 18, I was suddenly on a sugar trading desk in Paris, the most beautiful city" he says, "it was meant to be a short gap before joining the army." Instead Henry decided he enjoyed Paris more than a muddy German field, although he reflected with a smile, "I wish I had done short service or something similar but you can't do everything." From Paris, he moved to Mexico City to work for a coffee producer and shipper exploring commodity origins firsthand. "I didn't go to Brazil because they speak Portuguese and I wanted to learn Spanish."*

One linguistic choice helped shape future client relationships, particularly when working for a hedge fund based in Gibraltar and living in Sotogrande. He worked across Latin America *"I would fly to Miami and travel all points south, Colombia, Venezuela, Argentina, Chile, Peru - I was only 22 and it was great fun to go away on 6 week tours."* More importantly, building client trust so early taught Henry the value of connecting people and systems – a theme that has run throughout his professional and civic life.

## Returning to the City and Civic Life: From Finance to Founding C&E Capital

Returning to London, Henry joined GT (later Invesco), one of the world's largest investment houses, and worked there for nearly 20 years with institutional clients. In 2015, he decided to forge his own path *"Around 10 years ago, I set up my own business – C&E Capital – representing boutique fund managers and alternative investment strategies."* With C&E Capital, Henry has promoted everything from sector-specific equity funds and bond portfolios to hedge funds and, more recently, funds focused on white hydrogen and social housing. *"These are radically different themes, but that's what makes it exciting, being able to connect innovative ideas with the right audiences and watching them light up with the same enthusiasm I have. That same passion, connecting people with purpose, has been central in both my business and civic life."*

## A calling to serve: Civic Responsibility and Common Council

Henry felt increasingly drawn to the Square Mile's historic institutions, despite moving to the country following marriage. Already familiar with Livery through the Skinners, he wanted to contribute more than just a commuter's footprint. *"I asked myself, what else can I do beyond the desk? I wanted to stand for something."*

Rather than his local parish council, Henry set his sights on the City, particularly the Ward of Dowgate where Skinners' Hall had first inspired him as a boy. After losing his first election, he stood again in a by-election and was elected in 2002.

*"I've now served 23 years on various committees and boards."* Chairing the City of London Police authority Board was clearly meaningful, *"We have the smallest force in the UK geographically, but we lead nationally on economic and cyber crime. It was our armed unit that took out the terrorists during the London Bridge and Borough Market attack. I'm proud of that."* But not every experience has been as high. As Chair of the Markets Board, Henry oversaw the City's three historic wholesale markets – Billingsgate, Smithfield and New Spitalfields. *"With great sadness, by 2028, we won't be running a meat or fish market."* The City voted to give up control, a decision he believes will one day be regretted. *"Wholesale markets should be part of every great city."*



## The Role of Chief Commoner

Established in 1444, the role once involved overseeing City land and rent. If you fast forward 500 years, today it's part of a civic leadership team, alongside the Lord Mayor and Sheriffs, representing the City to its communities and international visitors. Among many other themes, three priorities emerged in our conversation, *"helping new Members integrate, we've had 60 elected since 2022; supporting investment management, my career for 40 years; and recognising the armed forces, especially veterans, reservists and cadets. People should appreciate how much the military does for us."* One unexpected legacy? A police horse named after him, PH Pollard, still on duty seven years later and the first animal to appear in an official Chief Commoner's portrait. Reflecting on transformation during his time he says, *"When I first arrived, the NatWest Tower was the tallest building. Now the skyline constantly evolves. That shows demand, ambition and growth."* And just like the skyline, the city's institutions evolve too, *"I was recently sat at a dinner with the Master of Entrepreneurs, a new Livery Company. A mix of ancient and modern. That's how the City stays relevant."* In the same way that the city has evolved, the role has evolved over time too, remaining relevant and preserving what makes the city special.

## Youth legacy and the Future: The Guild of Young Freemen and the Power of the Young

Henry joined the Guild of Young Freemen when it was still the Society of Young Freemen. *"The average age in the Corporation used to be around 75. That's no longer the case. There's greater diversity, more women, more young people, and more collective spirit among livery companies."*

It connects young professionals to centuries of tradition and teaches you how the Square Mile works: the Ward system, Aldermen, Court of Common Council — that knowledge opens doors, not just for service but for building community. *"I was curious. It was a way to understand the City from the inside. I never imagined I'd one day be Chief Commoner."*

Henry has introduced seventeen apprentices to the Skinners Company and helped many others find their way into civic life, actively interested in the next generation. *"I spoke to a Founding Warden of the Worshipful Company of Nurses who has one apprentice, who is also a member of the Guild of Young Freemen."* It's about finding what you enjoy, *"if you're an accountant then the Accountants' Company is meaningful, although liveries like the Fanmakers have evolved from the fans that people wave at society events to the aeronautical industry."* There's something for everyone and Henry emphasises it is about finding what excites you.

He also proudly supports the Guild of Investment Managers, which has a charitable mission helping people gain access to the industry through bursaries and qualifications. *"The great thing is opportunity. The City's always been inclusive. It's never blocked people based on background, race or gender. That's its strength."* Reflecting on legacy, Henry adds: *"We're part of a society moving forward. It's about doing your best in every role and inspiring the next generation to do the same."*

## Final reflections and Advice

Asking Henry about his guiding values, Henry is quick to answer: *"Have fun. Be Kind. Recognise that everyone has different strengths and help others grow, even if they're not like you."*

Henry's most vivid memory of the Society of Young Freemen was marching in the Lord Mayor's Show in freezing November weather, decades ago. *"We didn't have gowns back then, just red t-shirts. My sister turned blue, so we had to stop halfway for ginger wine in a pub to warm up."*

Looking back, Henry reflects on his three guiding pillars: *"Family and friends. My work. And the City of London Corporation, my great pro bono draw in life."*

His advice? *"Look into the City's electoral process. Stand for something. Give back. Be Charitable. Help your community however you can."*

As for the future of the City, he emphasises how stewardship, entrepreneurialism and community have pulled it forward, *"If we hadn't evolved, we wouldn't be relevant. And if we weren't relevant, we wouldn't still be here."*

*"...because we are still here, that means we're still relevant"*

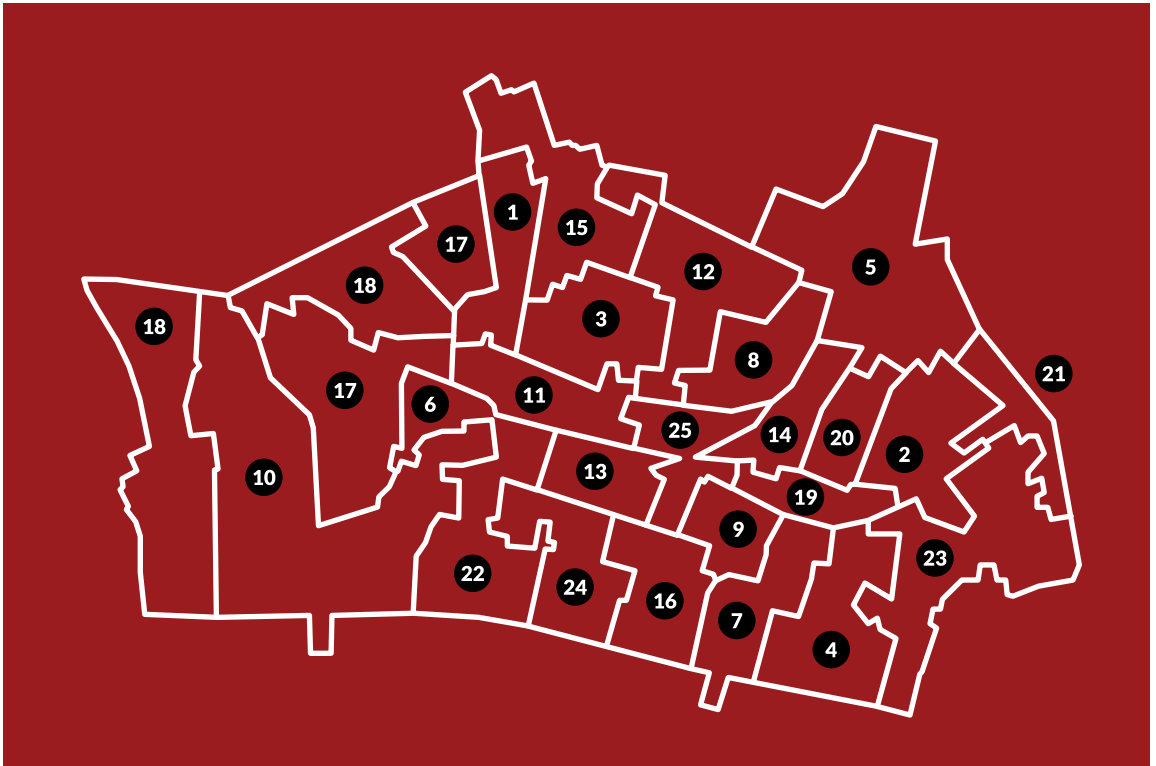

## The Wards of the City of London

The City of London is divided into 25 historic Wards, each with its own distinct character and identity. Originally established in medieval times, the Wards served as military, judicial, and administrative divisions, forming the backbone of civic organisation in the Square Mile. Over the centuries, their boundaries and roles have evolved in response to shifts in population, commerce, and electoral representation.

The 25 Wards of the City of London are:

2. Aldgate
3. Bassishaw
4. Billingsgate
5. Bishopsgate (Within and Without)
6. Bread Street
7. Bridge and Bridge Without
8. Broad Street
9. Candlewick
10. Castle Baynard

14. Cornhill
15. Cripplegate (Within and Without)
16. Dowgate
17. Farringdon Within
18. Farringdon Without
19. Langbourn
20. Lime Street
21. Portsoken

## The Composition of each Ward

Today, some Wards retain a predominantly residential character—such as Portsoken and Cripplegate—while others serve as major centres of commerce and industry. Wards like Aldgate and Billingsgate, for instance, are closely linked to the insurance and maritime sectors, respectively, underscoring the City's enduring position as a global business hub.

Each Ward's identity is shaped by a blend of historical legacy and contemporary dynamics. Some are home to significant residential populations, while others are dominated by business voters, often reflecting the nature of the firms headquartered within their boundaries. This variation is deeply rooted in the City's rich history, with livery halls, historic architecture, and centuries-old associations all contributing to the unique character of each Ward.

## Ward Clubs

Ward Clubs serve as social forums for both residents and workers, playing an important role in the civic life of the City of London. Though rooted in local tradition, these clubs are inclusive spaces that welcome voters and non-voters alike — bringing together individuals from diverse backgrounds who share a common interest in the City's heritage, its present workings, and its future.

In future editions, I will be offering a closer look at the composition of each Ward, including details on their voter base, the number of Common Councillors representing them, and general background information. I'll also highlight the activities of each Ward Club and their role in fostering civic engagement. This initiative will serve not only as a resource but also as an opportunity to **revitalise our engagement with the Ward Clubs** — encouraging more young Freemen to develop a deeper understanding of the City's structure and take a more active role in its civic fabric.

## The Worshipful Company of Armourers and Brasiers

Since England's inception, the nation has possessed a long and complex history when it comes to warfare. Whether defensive or offensive, from the Vikings to the Russians, the Land of the Rose has often found itself entrenched in battle, resulting in the high demand of one particular commodity: armour. Therefore, it comes as little surprise that the Company of Armourers and Brasiers', having celebrated its 700th anniversary in 2022, boasts its own vast and vibrant history steeped in the City of London's rich heritage.

Within the 14th century, recognized as an age of disorder and turbulence, flagged by events such as the Black Death, the Peasants'

Revolt and the Hundred Years' War, armour was a coveted industry. Historians will sadly admit, however, that there is little known about London's original armourers as they seldom documented their work for two very distinct reasons: the first due to the fact that many of the tradesmen were illiterate and, the second, because recording trade secrets on paper would have been considered risky business. Thus, their knowledge and skills were often passed by word of mouth until the year 1322 when the armourers gathered together and formed a unified front. In an effort to preserve the reputation of their trade as well as ensure that standards and protocols were maintained, the craftsmen



negotiated with the City of London authorities to create a legal agreement which would regulate their trade. While the document outlined specific regulations such as parameters over the quality of materials, its overarching intent was to establish a monopoly over the industry which would consequently stifle third-party tradesmen from conducting business within the City.

The agreement was a mutually beneficial enterprise as it allowed the City of London, in a time when the City was not fully autonomous, a sense of control over its commerce operations. And, while the Crown may have been satisfied with their new partnership, the work of the armourers did not always result in public favor. Within the cramped, overpopulated streets of London, residences squashed next to workshops, any tenants saddled beside an armourer's place of work would have been considered rather unlucky. One such resident is quoted complaining, "His great hammers shake the walls of our tenement, deprive us and our servants of rest by day and night, spoil the wine and ale in our cellar and fill our homes with the smoke of sea coal."

The final products of such a noisy craft were distributed amongst the army, from archers to spearmen to infantry. When picturing the ancient articles of the Armourers and Brasiers', one likely conjures images of the

traditional 'knight in shining armour', ready to charge into the fray of a battlefield. In reality, the armour produced during the time of the Livery's establishment was often constructed of materials including iron, leather, linen and other various textiles as opposed to the expected shining steel. It was not until decades later that the battle fashions evolved.

The 15th century hallmarked a period of advancement for the Company. Not only was a formal Court and apprenticeship scheme established but the overall trade itself had changed dramatically. Armour technology had developed into the usage of full plates of exposed armour, and it became fashionable to sport what, at the time, was called an 'all white' look. The new, bright and polished steel ensemble was often decorated with intricate designs influenced by lineage, status, regional styles and personal tastes. As the armour techniques progressed, so did the armourers themselves. On a cold December day in the year 1428, the Company had finally found themselves a home. Along the northern end of London's Coleman Street sat the Dragon Tavern and five small shops, all of which became the Armourers' new headquarters. The location was later moved further down the street to number 25 in the year 1837. The neoclassical exterior was designed by one of John Soane's (architect of the Bank of



England) pupils, Joseph Henry Good, with artificial stone figures flanking the Company coat of arms, dressed in medieval steel and brazen armour. Since its completion, the structure has remained relatively untouched apart for an incident in 1940 during the brutal London Blitz when the Hall was hit by an incendiary bomb. Luckily, a fireman had been passing by that evening and, in an act of heroism, broke inside to extinguish the fire. Any visitors of the Hall today can find a tribute to the 'unknown fireman' engraved on a decorative cartouche.

And, while the Company had situated itself in its new residence, the trade began to suffer a slow but steady decline. By the 17th century, wearing armour was a rare occurrence, ultimately posing a threat to the Company's and its members' livelihoods. Thus, the membership transitioned their work to the brasiers trade. From dishes and

pan to wares and cauldrons, the business of brassware offered regular demand, finalizing armour's transition from a status of necessity to antiquity. During the 1800's, the artifacts within the Company's collection, many of which had been donated by past masters, became of great interest to collectors, dealers and historians with the medieval armour relics being the most coveted. With their business sustained and legacy cemented, the Company began to shift its focus to charitable work. In 1979, the Gauntlet Trust was launched, its mission to merge accumulated charitable funds to support the Materials Science community. Today, the Armourers and Brasiers' Company maintains its efforts to promote Materials Science through its charity and networking pursuits, and its Hall remains a living testament to the Livery's storied past and enduring legacy.

## Meet our Members: Jessica Jue

Jessica Jue joined the Guild of Young Freemen in June 2024. She is a Freeman of both the Goldsmiths' Company and the Worshipful Company of Gold and Silver Wyre Drawers. Based at the prestigious Goldsmiths' Centre, she has exhibited her work with FIVE, a fine metal collective, and her stunning pieces have been acquired by the Victoria and Albert Museum for their permanent collection, as well as featured in the National Museum of Scotland and the Goldsmiths' Company Silver Collection.

This year, Jessica was selected to create the trophy for the first ever Women's event in the Intermediate category of the Royal Henley Regatta.

### **How were you selected to create the new trophy?**

I was invited to submit a proposal for "The Bridge Challenge Plate" trophy alongside a few other silversmiths. After several days of research and extensive design work, I was absolutely delighted to learn that my design had been selected. It was particularly exciting, as I had never been approached to

design anything like this before, and I was thrilled to contribute my artistic vision to such a prominent commission.

### **What was your design process?**

My design process for this trophy involved extensive sketching, model-making and CAD



work, which was quite different from my usual fluid and intuitive approach. For this specific commission, there were many factors to consider, such as functionality, practicality and the trophy's longevity, so I had to carefully think through every step of the piece's construction. It was especially satisfying to then apply my signature style of fluid, painterly strands of gold to the surface, thoughtfully combining shape and pattern into a cohesive whole.

**How have you incorporated the themes of Thamesis and Isis, and did you draw anything from the original creator being a woman (Ann Seymour Damer), unique in her field at that time?**

The concept embodies the theme of connection, merging the iconic sculptures of Isis and Tamesis from Henley Bridge with the dynamic energy of swirling gold and rippling water. This flowing, layered design symbolises the fluidity of progress, the determination of athletes striving for excellence, and the artistry that reflects both the sport of rowing and Henley's rich cultural legacy.

Inspired by the original sculptures by 18th-century artist Ann Seymour Damer, an extraordinary woman who was one of the few recognised female sculptors of her time, the piece weaves in her legacy through a distinctly feminine and fluid aesthetic. The gold strands intertwine with the figures, echoing the movement of water and honouring the ongoing contributions of women in both art and sport. Damer's pioneering spirit is reflected in the design's

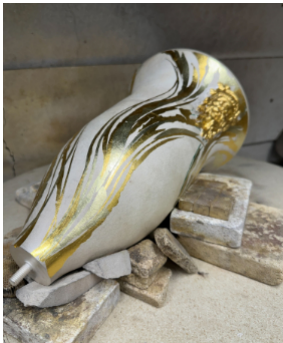
balance of elegance, strength and historical resonance.

**The race and the trophy are created to increase parity in the event, bringing the number of women's races closer again to the men's. Have you felt the importance of this during the design process?**

Absolutely, the importance of increasing parity between women's and men's races was something I felt deeply throughout the entire design process. Knowing that this trophy would represent a meaningful step towards greater equality at such a historic and prestigious event gave the commission an added sense of purpose. I was very conscious of designing something that not only celebrated the athletic excellence of the competitors but also honoured the significance of this moment for women in sport. That awareness informed both the symbolism and the form of the piece, from the flowing, interconnected elements that suggest unity and progress, to the inspiration drawn from Ann Seymour Damer, a pioneering female sculptor. It felt like a powerful opportunity to contribute artistically to a broader cultural shift.

**Describe the process of making the trophy. Will it be a traditional style trophy? I can see a lot of your work has a contemporary feel and is very sculptural and textured. What techniques do you use?**

The trophy is a contemporary piece crafted using traditional silversmithing techniques.



Its creation involved a wide range of skills, including hammering, soldering, spinning, gold fusing, casting, polishing and engraving, many of which were carried out with the help of a few incredibly skilled craftspeople.

My work is known for its organic and sculptural qualities, and many of my signature techniques were applied to this trophy as well. These include surface texturing with a hammer and the use of Keum-Boo, an ancient Korean technique. I begin by alloying the specific colours of gold I need and rolling them out into thin sheets of foil, which are then fused onto silver using heat and pressure. This process creates a strong, permanent bond through the exchange of electrons between the metals. For this trophy, both 18ct green gold and 24ct yellow gold foil were fused to the surface using this method.

### **How many hours does it take to create the piece?**

The last few months have felt like a bit of a blur, and it is difficult to say exactly how much time went into making this trophy. I estimate that at least two solid months were spent purely on the making process alone.

In the past, I have taken on commissions from museums such as the V&A Museum and the National Museums Scotland. However, the most challenging part of this project was undoubtedly taking on a functional commission of this scale and complexity for the first time. Fortunately, I was lucky to have several experienced makers around me who generously shared their knowledge and helped make the journey as smooth as possible.

I would especially like to thank master silversmith Clive Burr, who is based at the Goldsmiths' Centre, where my studio is also located. Clive has been incredibly generous with his time and expertise, guiding me from start to finish, beginning with technical drawings and continuing through to the construction and final finishing of the piece.

This experience has truly inspired me, and I

look forward to pursuing more large-scale works like this in the future.

### **Have you enjoyed designing and making the trophy? How does it feel to be creating something for such a prestigious event? Some of the trophies are now over 100 years old. How does it feel to know that this may be your work someday that someone will be lifting aloft?**

Designing and making the trophy for Henley Royal Regatta has been an incredibly rewarding experience. I have truly enjoyed the process; it has definitely pushed me creatively and technically in ways that have helped me grow as a maker. Being given the opportunity to create something for such a prestigious and historic event has been a real honour.

Knowing that this trophy could become part of Henley's long tradition, alongside trophies celebrated for over a century, is both humbling and surreal. The thought of the winners lifting this trophy high in victory is incredibly exciting. The idea that it might hold personal meaning for them fills me with pride and joy. It is a privilege to contribute a small chapter to such a rich legacy.

### **You discovered the world of Livery Companies through your education and profession. As a trade freeman, how have your livery companies supported you in your journey in jewellery making and silversmithing?**

My introduction to the world of livery companies came through my education and early professional experiences, with the Goldsmiths' Company playing a pivotal role in shaping my development as a silversmith and jeweller. Since completing my training, I have remained closely connected with the Goldsmiths' Centre, where I am now based and continue to develop my practice in my workshop.

Exhibiting at Goldsmiths' Fair has been a turning point in my career, offering invaluable

exposure and the opportunity to connect with a wider audience. In 2021, I was honoured when the Company commissioned my Whispering Reeds Beaker for its Collection. This experience affirmed my path and deepened my appreciation of the Company's commitment to contemporary craftsmanship. I have also been fortunate to receive several awards through the Goldsmiths' Craft and Design Council, which have recognised and encouraged my creative progress.

In addition to the Goldsmiths' Company, I am also a member of the Wyre Drawers Company, who have been wonderfully supportive in introducing me to their wider network and in championing artist-makers. Their efforts to support makers through fairs and exhibitions have provided valuable platforms to share my work and engage with new audiences.

Both the Goldsmiths' and Wyre Drawers companies have provided me with professional opportunities, mentorship and encouragement at key stages of my journey. These experiences have been instrumental in my growth as a maker and have instilled in me a strong desire to give back, to support the next generation of craftspeople, share knowledge and contribute to the vibrant future of our craft.

**Finally, what does it mean for you to be a member of the Guild of Young Freemen?**

What I love about the Guild of Young Freemen is the opportunity to meet and connect with young professionals across a wide range of industries. It has been inspiring to share experiences with like minded individuals who are equally passionate about their work and their place in the City's future.

To me, the Guild represents a space where tradition meets modern ambition, a place to grow together and be part of a community that supports one another.

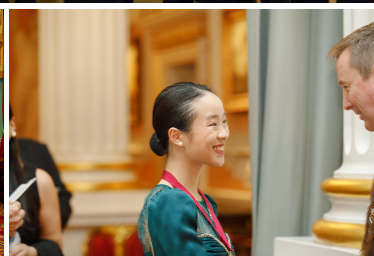
